### Methodology

### Your Voice October 2024

Survey Type: An omnibus, controlled-access online CFIB survey.

Survey period: October 10 - November 07, 2024.

**Sample:** Based on responses from 3,003 CFIB members who are owners of Canadian independent businesses, from all sectors and regions of the country. For comparison purposes, a probability samples with the same number of respondents would have a margin of error of +/-1.79%, 19 times out of 20.

Purpose and Context: The CFIB *Your Voice* omnibus survey is conducted bi-monthly, focusing on issues that matter most to small business owners across Canada. For over five decades, CFIB has harnessed the collective voice of its members to produce data-driven policy strategies that reflect the needs of small businesses. Our in-house survey capacity is a powerful tool designed to empower business owners to share insights on topics from government support to regulatory burdens.

Impact: The survey's insights are gathered directly from CFIB members, ensuring an authentic representation of small business priorities. These responses help shape CFIB's advocacy efforts, driving policies that are aligned with the evolving needs of the small business community.



# Survey insights

The CFIB's October Your Voice survey dives into the pressing priorities of Canadian businesses, spotlighting their top policy concerns and needs for government support. Here are the key findings from this month's responses:

### Low Confidence in Government Support

Canadian business owners are feeling the strain, with nearly two-thirds expressing a lack of confidence that their provincial or territorial government is truly supportive of their interests. Alberta leads in relative confidence levels, while Quebec sees the lowest figures, suggesting that support for small business varies widely across provinces.

### Tax Cuts on the Agenda

Tax relief is high on the priority list, with a strong call to reduce the small business corporate income tax, personal income tax, carbon tax, and gasoline/fuel taxes. Interestingly, some provinces—particularly Alberta, Manitoba and Saskatchewan—place a higher emphasis on carbon taxes, indicating region-specific tax concerns.

#### **Federal Election Priorities**

As federal election discussions emerge, business owners are clear on what they want to see prioritized: controlling government spending, reducing the small business tax rate, and eliminating the carbon tax. Western provinces, in particular, are keen on carbon tax reductions, reflecting a regional push for policies to lower operational costs.

#### Mixed Views on Tariffs

The introduction of a 25% tariff on steel and aluminum imports from China garners mixed support, with about half of the business community in favor. Notably, the construction sector leads in support for this measure, signaling a sector-specific push.

In summary, the October survey presents a focused view of the policy areas where business owners seek immediate action, guiding policymakers on the support and reforms that small businesses need most.





# Confidence in the provincial/territorial government











# Taxation

#### Top tax cut priorities





Most provinces prioritize reducing small business corporate income tax, followed by personal income and carbon taxes, though in Alberta, Manitoba and Saskatchewan carbon taxes take precedence over personal and small business corporate income taxes.



Most sectors prioritize small business income tax cuts, especially Arts, Recreation & Information, Personal, Misc. Services, Social services, Hospitality and Wholesale. While Finance, Insurance & Real Estate, and Transportation prioritize personal income tax cuts.





# Federal priorities

Business owners prioritize federal election platforms that address controlling government spending and debt, reducing the federal small business tax rate, eliminating the carbon tax, reducing regulatory burdens, and increasing the small business tax threshold.



Top federal priorities to include in election platforms, by province












# Tariffs





Q2 2024 - Entrepreneurship in Canada is improving, but still not fully back to prepandemic strength.




Private Sector Job Vacancies in Canada
