Methodology

Your Voice July 2025

Survey Type: An omnibus, controlled-access online CFIB survey.

Survey period: July 10 - July 24, 2025.

Sample: Based on responses from 2,090 CFIB members who are owners of Canadian independent businesses, from all sectors and regions of the country. For comparison purposes, a probability samples with the same number of respondents would have a margin of error of +/-2.14%, 19 times out of 20.

Purpose and Context: The CFIB Your Voice omnibus survey is conducted bi-monthly, focusing on issues that matter most to small business owners across Canada. For over five decades, CFIB has harnessed the collective voice of its members to produce data-driven policy strategies that reflect the needs of small businesses. Our inhouse survey capacity is a powerful tool designed to empower business owners to share insights on topics from government support to regulatory burdens.

Impact: The survey's insights are gathered directly from CFIB members, ensuring an authentic representation of small business priorities. These responses help shape CFIB's advocacy efforts, driving policies that are aligned with the evolving needs of the small business community.

Note: In some instances, responses may not add up to 100% due to rounding.



July Your Voice Survey Insights

The July 2025 edition of Your Voice captures the latest views of small business owners across Canada. Spanning over 2,000 responses, the survey highlights the ongoing pressures facing entrepreneurs—from rising costs to shifting trade dynamics—and outlines the actions needed to foster business growth and resilience.

Tax Relief and Investment Priorities

When asked how meaningful tax relief would affect their operations, most small business owners pointed to immediate cost relief and longer-term growth. Over half (55%) would use it to stabilize operations or manage rising costs, while more than one in three (35%) said they would invest, grow, or expand their business.

Small business corporate income tax was the top area identified for cuts, followed by personal income and sales taxes. Savings would primarily go toward boosting staff pay, reducing debt, and expanding operations.

Trade Environment

Tariff impacts from the U.S.-Canada trade tensions continue to weigh heavily on businesses, especially those involved in trade. In response to the trade war risks, businesses say they've raised prices (40%), turned to domestic suppliers (36%), or absorbed extra costs (31%). Tariffs on U.S. imports were reported almost six times more often than on exports. Most businesses are absorbing tariff costs—either alone or through cost sharing. On exports, 63% covered costs directly or shared them. On imports, 67% paid the full tariff without supplier adjustments.

Infrastructure Outlook

There is strong support among small businesses for faster approvals of national infrastructure projects. Most say these improvements would help grow the economy, improve transportation and supply chain access, and attract investments in local communities. At the same time, many feel overlooked in planning and execution, and worry that accelerating projects may reduce attention to environmental impacts.

These findings reflect a business community focused on cost control, predictable trade conditions, and smarter public investment. Continued advocacy and targeted policy will be key to meeting their evolving needs.



Most Likely Use of Tax Relief by Small Businesses







Question: If governments (federal, provincial/territorial and municipal) were to reduce taxes, which areas should be prioritized for tax cuts? (Select all that apply)




Question: If governments at any level were to reduce the overall burden of taxes and fees, where would you allocate your savings? (Select all that apply)

Business Actions Taken to Manage Trade Risks








Exporters were more likely to absorb tariff costs, raise prices, or delay expansion; Importers were more likely to raise prices and shift to domestic suppliers.



Share of Small Businesses Affected by U.S. or Canadian Tariffs












Business Sentiment on National Infrastructure Planning and Approval










By location of the business




By number of employees



By years in business




