


## Business Barometer Index and GDP (September 2016)


### **High Priority Issues**


# How confident are you that the federal government has a vision to support small business and entrepreneurship? (% response)

Smaller Employer (net of Small Business Job Credit applied in 2015 and 2016*)	2.24	2.28



#### Recommendations

- ▶ Reinstate the reduction of the SBTR to 9% by 2019.
- ▶ Introduce a permanent, lower rate EI rate
- ► Implement an EI holiday for youth
- ▶ Balance the budget within 3-5 years
- Introduce an "Innovation Lens"
- ► Fewer unnecessary government regulations
