

I am concerned that you and other Municipal leaders may consider **increasing property taxes** again in 2018.

While I recognize Saskatchewan municipalities will receive a decrease in **municipal revenue** sharing in 2017-18, due to a decline in PST revenue, the reality is the province will still distribute \$258 million, a 103% increase since 2007-08. <u>In fact, Cities have received a 156% increase since</u> 07-08.

I urge you to <u>further contain costs</u> and AVOID A PROPERTY TAX HIKE IN 2018 by:

- Limiting operational spending growth to a maximum of inflation plus population growth;
- ► Identifying programs/services that can be eliminated, streamlined or contracted out to the private sector or sold; and
- ► Introducing a plan to reduce the size/cost of the municipal civil service (primarily through attrition) and pension reform.
