<u>I am concerned some municipalities</u> have recently claimed they need more revenues and <u>want the Saskatchewan government to give them the authority to levy new taxes</u> (e.g. local fuel, income or sales taxes).

I am opposed to this idea. In fact, a CFIB survey found 82% of Saskatchewan business owners oppose municipalities having the authority to levy new taxes.

My key concerns are:

- It would increase the overall tax burden;
- It would promote overspending & duplication with other levels of government; and
- There are three levels of government, but only one taxpayer.

In response to CFIB's 2017 Leadership Candidates' survey, the Premier said:
