## One Year In: Cannabis in the Workplace Survey


Preliminary Results

## Methodology

- Survey was conducted online October 9 TBD (online).
- Received 5,710 responses from small business across Canada.
- For comparison purposes, a probability sample with the same number of respondents would have a margin of error of +/-1.3%, 19 times out of 20.






Q2. Who is your primary source(s) of information related to cannabis in the workplace? (% response) – multiple response question




Q2a. Has the information helped you feel more confident/better equipped to deal with cannabis in the workplace? (% response)
