







COVID-19: State of Small Business

Key results— Week 13

Overview

During the COVID-19 pandemic, *CFIB* has been sending frequent "Your Business and COVID-19" surveys to our members to understand how businesses are being impacted, how they are adapting to the "new normal" and what support they need.

Decline in the number of responses in later surveys is normal, given the comparatively large sample sizes attained in earlier surveys. It could also be the consequence of other factors, such as survey fatigue, increased competition for respondents' attention and time, a switch from an "emergency situation" to a "new normal", etc.

Beginning with Survey No. 11, we have left the survey in the field for a longer period and incorporated a reminder for respondents.



Methodology



Online survey (Your Business and COVID-19 – Survey Number Twelve) started June 6.



So far, Survey Number Twelve has received a total of 4,759 responses from small businesses across Canada.



For comparison purposes, a probability sample with the same number of respondents would have a margin of error of +/-1.4%, 19 times out of 20.



Note on the next pages: The percentage of responses in charts may not always add up to 100%, due to rounding or multiple choice responses. There are instances in in this briefing that we do not report on certain provinces and sectors, as the sample size is less than 40 respondents.



(% response)


















- Don't know/Unsure





(% response)





Has your landlord chosen to use the CECRA program to provide rent relief for your business?





As a *landlord*, is your business participating in the CECRA program to provide rent relief for its tenants? (% response)





How would you rate your business's overall experience with the CECRA program, including the application? (% response)



Regarding your business banking, are you in a situation where you are using a personal bank account and do not have a business bank account?



Which of the following best describes your current business situation regarding the Canada Emergency Business Account (CEBA)?





Businesses that applied to and received funding through CEBA - Please indicate how helpful CEBA has been in addressing your business's current challenges?








"Our business can cope with additional costs right now"






"Our business can cope with additional costs right now" (% response)
